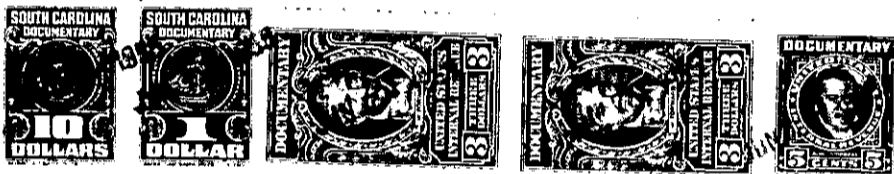
Edward J. Tanner, his heirs and assigns forever:
