ALL that certain piece, parcel or lots of land in Chick Springs Township, Greenville County, State of South Carolina, being known and designated as Lots Nos. 13 and 15 on Plat of Pine Brook Development, made by W. N. Willis, Engineer, dated March 27, 1951, recorded in the R.M.C. Office for Greenville County in Plat Book "Z", at Page 148, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the Northeastern side of Keasler Street, joint front corner of lots 11 and 13, thence along common line of said lots, N.56-29 E. 150 feet to an iron pin; thence along rear line of lots 62 and 60, N.30-52 W. 150 feet to an iron pin, joint rear corner of lots 15 and 17; thence along common line of said lots, S.56-29 W. 150 feet to an iron pin on Keasler Street, (now Elaine Drive); thence along Keasler Street, (now Elaine Drive) S.33-31 E. 150 feet to an iron pin, the point of beginning.
