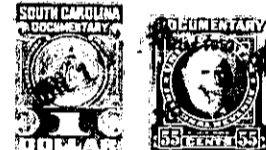
JAMES I. HENRY, HIS HEIRS AND ASSIGNS, FOREVER,

All that certain piece, parcel or lot of land in Check Springs Township, Greenville County, State of South Carolina, being known and designated as Lot No. 86 Sherwood Forest as shown on a plat thereof recorded in the R.M.C. Office for Greenville County, South Carolina in plat Book "Y", page 23, and having according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the Southern side of Easy Street joint front corners of lot Nos. 85 and 86; thence S. 43-00 E. 200 feet to an iron pin joint rear corner of Lots Nos. 77, 78, 85 and 86; thence N. 47-00 E. 50 feet to an iron pin joint rear corner Lots Nos. 86 and 87; thence along common line of Lots Nos. 86 and 87 N. 43-00 W. 200 feet to an iron pin on Easy Street; thence along the edge of Easy Street S. 47-00 W. 50 feet to an iron pin point of beginning.

This deed is made subject to restrictions applicable to Sherwood Forest and recorded in the R.M.C. Office for Greenville County, S. C. in deed book 412, page 149 and further subject to utility easements of record.
