All my right, title and interest in and to all that piece, parcel or lot of land in the City of Greenville, County of Greenville, State of South Carolina, having the following metes and bounds:

BEGINNING at a point on Washington Street 143.7 feet East of G. W. Taylor line and running thence with Washington Street S. 50 3/4 E. 72 feet to the corner of Washington and Hudson Streets; thence with Hudson Street N. 26 E. 163 feet to a stake; thence N. 50 3/4 W. 53 feet and thence 158 feet to the beginning corner on Washington Street.

This is a portion of the property conveyed by Colin M. Hudson, Mary McCann Hudson and Dugald W. Hudson to Coline M. Hudson by deed dated May 24, 1947, and recorded in the R. M. C. Office for Greenville County in Deed Volume 313 at page 376. In this deed one of the dimensions of the lot herein conveyed was erroneously stated as 136 feet where it should have been 163 feet, and this deed is given to correct this error.
