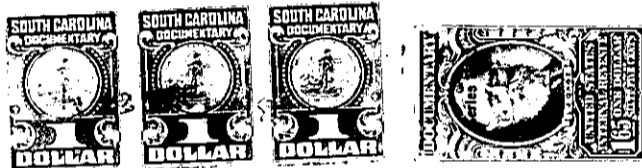
R. J. NEWTON, HIS HEIRS AND ASSIGNS,

ALL that certain piece, parcel or lot of land in Chick Springs Township, Greenville County, State of South Carolina, being known and designated as Lot No. 55 as shown on plat of Pine Brook Development made by W. N. Willis, Engineer, on March 27, 1951, recorded in the R.M.C. Office for Greenville County in Plat Book "Z", at Page 148, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the Eastern side of Brewster Drive, at the joint front corner of lots 53 and 55 and running thence along common line of lots 53 and 55, N. 56-29 E. 150 feet to an iron pin, joint rear corner of said lots; thence along rear line of lots 78 and 55, S. 33-31 E. 75 feet to an iron pin, joint rear corner of lots 55 and 57; thence along common line of said lots, S. 56-29 W. 150 feet to an iron pin on Brewster Drive; thence along Brewster Drive, N. 33-31 W. 75 feet to the point of beginning.

This conveyance is made subject to the Restrictive and Protective Covenants applicable to Pine Brook Development and recorded in the R.M.C. Office for Greenville County, South Carolina, in Book of Deeds 443, at Page 307, and Book of Deeds 462, at Page 33.
