to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said

Benis G. Carnes, his heirs and assigns forever:

All that piece, parcel or lot of land situate, lying and being in Gantt Township, Greenville County, South Carolina and being known and designated as Lot No. 87 of Pecan Terrace according to a plat thereof prepared by Piedmont Engineering Service dated March 27, 1953 and recorded in the R. M. C. Office for Greenville County in Plat Book "GG", page 9 and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the eastern side of Twin Springs Drive, joint front corner of Lots Nos. 86 and 87 and running thence along said Drive S. 16-55 E. 60 feet to an iron pin, joint front corner of Lots Nos. 87 and 88; thence along the joint side line of said lots S. 87-28 E. 171.3 feet to an iron pin, joint rear corner of said lots; thence N. 22-22 W. 129.6 feet to an iron pin, joint rear corner of Lots Nos. 86 and 87; thence along the joint side line of said lots S. 68-25 W. 150.1 feet to an iron pin, the point of beginning.

TO HAVE AND TO HOLD all and singular the said Premises before mentioned unto the grantee(s) hereinabove named, and his Heirs and Assigns forever.

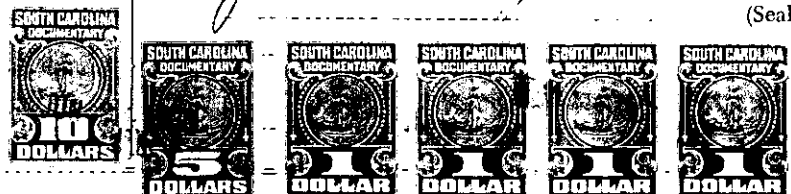
