Know All Men by These Presents:

That I, J. P. Medlock, of Greenville County in the State aforesaid, in consideration of the sum of Nine Thousand, Four Hundred and No/100 - (\$9400.00) DOLLARS,

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said grantee(s) Raymond F. Eison, his heirs and assigns forever:

All that certain piece, parcel or lot of land situate, lying and being in the State of South Carolina, and within the corporate limits of the City of Greenville, being known and designated as Lot No. 11 of a subdivision known as Maple Heights as shown on plat thereof prepared by C. C. Jones, C. E., June, 1954 and recorded in the R. M. C. Office for Greenville County in Plat Book HH, at page 49, and having, according to said plat, the following metes and bounds, to-wit:

"BEGINNING at an iron pin at the northeastern corner of the intersection of the Lowndes Hill Road with Oakland Drive, and running thence along the northeastern side of Oakland Drive, N. 27-45 W. 150.8 feet to an iron pin at the corner of Lot No. 12; thence along the line of that lot, N. 62-15 E. 80 feet to an iron pin at the rear corner of Lot No. 10; thence along the line of that lot, S. 27-45 E. 155.1 feet to an iron pin on the northwestern side of the Lowndes Hill Road; thence along the northwestern side of the Lowndes Hill Road, S. 65-15 W. 80 feet to the beginning corner, being one of the lots conveyed to me by Marshall F. Vaughan by deed dated January 28, 1955 and recorded in the R. M. C. Office for Greenville County in Vol. 517, at page 169."

The above described property is shown on the Township Block Book at Sheet 193, Block 1, Lot 155, and the grantee is to pay taxes for the year 1955, said taxes having been pro-rated as of this date.

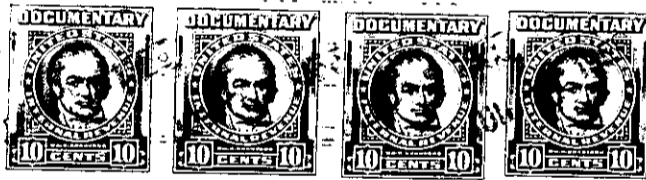
