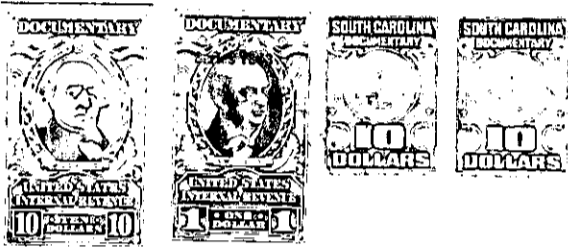
Know All Men by These Presents:

in consideration of the sum of Nine Thousand, Seven Hundred, Fifty and No/100 DOLLARS,

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Edward Bryant, his heirs and assigns forever:

All that certain lot of land in Paris Mountain Township, Greenville County, State of South Carolina, and being known and designated as Lots Nos. 3 and 4 as shown on plat of property of James B. Green prepared by W. J. Riddle, April 1949, recorded in the Office of R. M. C. for Greenville County in Plat Book V at Page 163, and being more particularly described, according to said plat, as follows:

BEGINNING at an iron pin on the eastern side of Razor Drive, joint corner of Lots Nos. 4 and 12, and running thence with joint line of said lots, S. 78-06 E. 219.9 feet to an iron pin in line of Lot No. 1; thence along line of Lots 1 and 2, S. 12-17 W. 155.2 feet to an iron pin in line of Lot No. 10; thence N. 74-35 W. 237 feet to an iron pin in the east side of Razor Drive; thence with said drive, N. 18-43 E. 140 feet to the point of beginning. Being the same conveyed to me by James B. Green, Jr. by deed dated July 20, 1951 and recorded in the R. M. C. Office for Greenville County in Deed Book 439, at Page 130.
