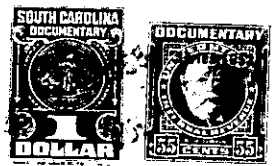
That I, Annie T. Henderson in consideration of the sum of Four Hundred (\$400.00) in the State aforesaid, DOLLARS,
