to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said W. E. Bannister, his Heirs and Assigns, forever:

All that certain piece, parcel or lot of land in Chick Springs Township, Greenville County, State of South Carolina, on the Western side of Elizabeth Drive and being shown and designated as Lot No. 238 on Plat of the property of Robert J. Edwards recorded in the R.M.C. Office for Greenville County in Plat Book EE, at page 61, and having, according to said Plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the Western side of Elizabeth Drive, at the joint front corner of Lots Nos. 238 and 237, and running thence with the line of Lot No. 237, S. 56-30 W. 200 feet to an iron pin; thence N. 33-30 W. 100 feet to an iron pin in rear corner of Lot No. 239; thence with the line of Lot No. 239, N. 56-30 E. 200 feet to an iron pin in Elizabeth Drive; thence with the Western side of Elizabeth Drive, S. 33-30 E. 100 feet to the beginning.
