Know All Men by These Presents:

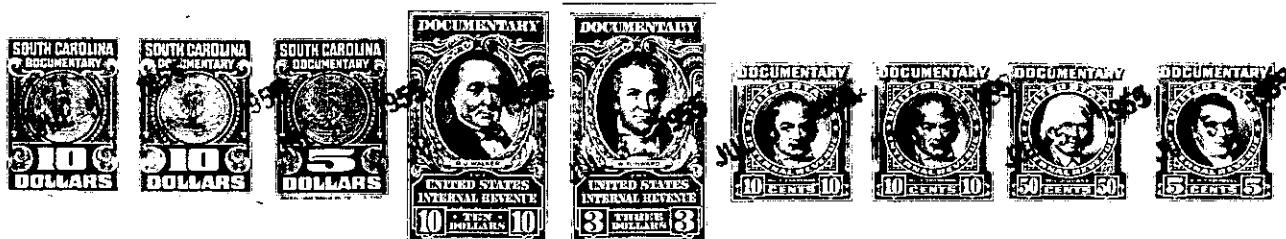

All that lot of land in Gantt Township, Greenville County, state of South Carolina, being known and designated as Lot No. 11 on plat of property of Donald E. Baltz prepared by Dalton & Neves, 1954, recorded in the R. M. C. Office for Greenville County in plat book HH page 169, and having according to said plat the following courses and distances to-wit:

Beginning at an iron pin on the southeastern side of Crestfield Road, the front joint corner of Lots Nos. 10 & 11, and running thence with the joint line of said lots S. 39-54 E. 198.9 feet to an iron pin; thence N. 49-44 E. 70 feet to an iron pin corner of lot No. 12; thence with the line of said lot N. 39-54 W. 198.5 feet to an iron pin on the southeastern side of Crestfield Road; thence with the southeastern side of said road S. 50-06 W. 70 feet to the beginning corner.

This lot is conveyed subject to the building restrictions applicable to this property recorded in deed volume 516 page 17 of the R. M. C. Office for Greenville County and subject to easements and rights of way of record.
