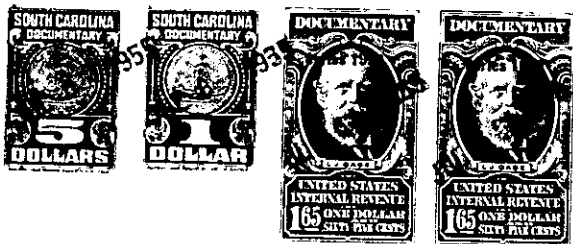
That I, Eules Morgan, on the 6th day of July, 1955, Know All Men by These Presents:
