L. QUINN, his heirs and assigns:

All that lot or parcel of land in Greenville Township, Greenville County, State of South Carolina, and being known and designated as Lot No. 113 on a revised Map of Parker Heights made by Dalton and Neves, Lay, 1949, recorded in the R.M.C. Office for Greenville County, S. C. in Plat Book "P", page 43, and having according to said plat, the following metes and bounds, to-wit:
