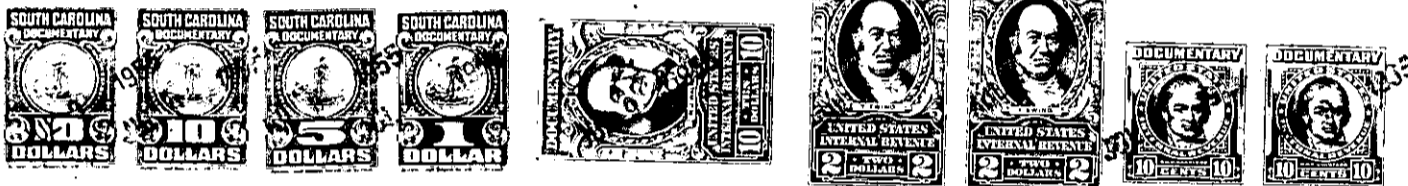
That I, Alice W. Gilstrap in the State aforesaid,

Gilreath, Jr., his heirs and assigns forever:

All that lot of land, with the improvements thereon, situate in the County of Greenville, State of South Carolina, near Greenville, S. C. being known as lot no. 7 according to plat of property of Alice W. Gilstrap made by Piedmont Engineering Service dated May, 1954 and recorded in the R.M.C. Office for Greenville County in Plat Book HH at Page 63 and having, according to said plat the following metes and bounds, to-wit:

Beginning at an iron pin on the northern side of Galphin Drive, at the joint corner of lots nos. 7 and 1, which iron pin is situate 220.15 feet west of the intersection of McCarter Shop Road and Galphin Drive and running thence on the northern side of said Drive, S 80-03 W, 140.5 feet to an iron pin, corner of lot no. 8; thence with the line of lot no. 8, N 10-16 W, 243.5 feet to an iron pin in the line of lot no. 5; thence with the line of lots nos. 5, 4, 3, 2, S 41-30 E, 266.3 feet to an iron pin, corner of lot no. 1; thence with said lot, S 14-12 E, 16.7 feet to the point of beginning, being the same property conveyed to me by E.
