

All that piece, parcel or lot of land, situate, lying and being in the City of Greenville, Greenville County, South Carolina, and being known and designated as Lot No. 5 of Rasor Realty Company property, as shown on a plat thereof prepared by Will D. Neves and recorded in the R. M. C. Office for Greenville County, S. C., in Plat Book "L", at page 34, excepting a small strip taken therefrom to widen the alleybay, and having according to a revised plat by w. D. Neves, April 1920, the following metes and bounds, to-wit:
