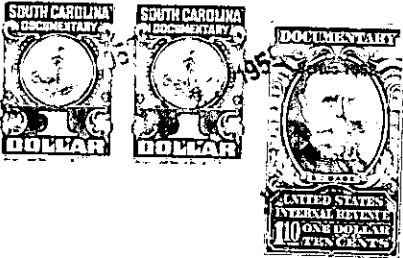
Know All Men by These Presents:

Beginning at an iron pin on the North side of Highland Street at the S. E. corner of Lot No. 29, and runs thence N. 77-35 E. 100 feet along said highland Street to a stake; thence N. 9.11 W 204 feet along line of lot No. 32, to a stake; thence S 67-15 W 100 feet to a stake, corner of lots # 29 and 30; thence S. 8-25 E 183.7 feet to the beginning corner, and being lots Nos. 30 and 31 as per Blue Print by H. S. Brockman, surveyor, under date of May 9, 1947, recorded in R. M. C. Office for Greenville County in Plat Book R at page 81.
