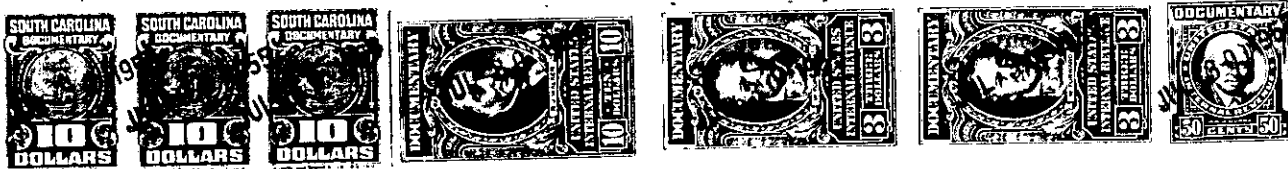
That I, J. H. Mauldin, in the State aforesaid,

R. Hamil and Alma J. Hamil, their heirs and assigns forever:

All that piece, parcel or lot of land situate, lying and being in and near the City of Greenville, in Greenville County, South Carolina and being known and designated as Lot No. 29, Section H of Croftstone Acres according to a plat thereof recorded in the R. M. C. Office for Greenville County in Plat Book "Y", at Page 91 and having according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on the northern side of Broughton Drive, joint front corner of Lots Nos. 28 and 29 and running thence along said Drive N. 72-25 E. 70 feet to an iron pin, joint front corner of Lots Nos. 29 and 30; thence along the joint side line of said lots N. 17-35 W. 200.4 feet to an iron pin, joint rear corner of said lots; thence S. 72-49 W. 70 feet to an iron pin, joint rear corner of Lots Nos. 28 and 29; thence along the joint side line of said lots S. 17-35 E. 200.9 feet to the beginning corner.
