Durham's corner; thence north 11 degrees west 10 chains to a stake; thence north 11 1/2 degrees west 10 chains to a stake on road; thence North 78 degrees west 7 chains to the mouth of the William Fisher Spring branch; thence North 11 degrees west 1.50 chain with the branch to stake; thence in a westerly direction the branch as it meanders 25 chains to a stake in Tryon Water Company line; thence South with said line 40 chains to a stake bearing North 62 degrees 1.25 chains from a Chestnut Oak, a corner on the old line; thence North 62 degrees west 53.25 chains to the beginning, containing one hundred and twenty acres, more or less.
