Know All Men by These Presents:

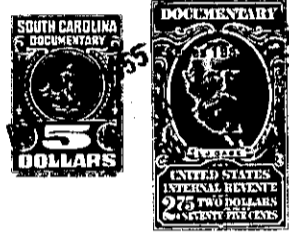

RUSSELL STOVER, his heirs and assigns:

All that piece, parcel or lot of land, situate, lying and being near the City of Greenville, in the County of Greenville, State of South Carolina, being known and designated as Lot No. 18, according to Plat of Section I of Lake Forest, which plat is recorded in the R. M. C. Office for Greenville County, South Carolina, in Plat Book "GG", page 17, and having, according to said plat, the following metes and bounds, to wit:

BEGINNING at an iron pin on the Westerly side of Lake Fairfield Drive, joint front corner Lots 17 and 18, and running thence S. 48-0 W. 198.8 feet to an iron pin, joint rear corner Lots 17 and 18; thence N. 7-44 W. 75 feet to an iron pin, joint rear corner Lots 18 and 19; thence N. 75-37 E. 205.8 feet to an iron pin on the Westerly side of Lake Fairfield Drive; thence along the curve of Lake Fairfield Drive, the chord of which is S. 4-37 E. 108 feet to an iron pin, the point of beginning.
