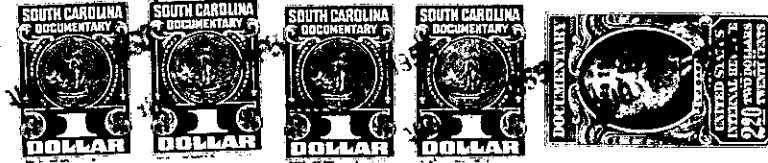
H. E. THOMASON, JR., His Heirs and Assigns:
