All that certain piece, parcel or lot of land in Chick Springs Township, Greenville County, State of South Carolina, on the Western side of Elizabeth Drive, being shown as Lot No. 325 on Plat of Cherokee Forest recorded in the R.M.C. Office for Greenville Co nty in Plat Book EE, at pages 78 and 79, and having, according to said Plat, the following metes and bounds, to-wit:
