RELEASE OF JUDGMENT

Whereas Ross Builders Supplies, Inc., a corporation, is the owner and holder of a Judgment against Palmetto Realty Corporation, et al, which Judgment is filed for record in the Office of the Clerk of Court of Greenville County, South Carolina in Judgment Roll F-729, and,

Whereas the said Ross Builders Supplies, Inc. has heretofore released certain lots formerly owned by Palmetto Realty Corporation and situate on Morris Court near the City of Greenville, and,

Whereas each of said deeds referred to a street known as Morris Court, and,

Whereas the said Morris Court, although dedicated to public use prior to the filing of the above referred to Judgment, was not deeded to the County of Greenville until January 31, 1955, as will appear by deed recorded in the R. M. C. Office for Greenville County in Deed Book 517, page 293, which was after the date of the filing of the said Judgment, and,

Whereas some question might be raised about the lien of said Judgment as against the said street.

NOW THEREFORE, for value received, Ross Builders Supplies, Inc. does hereby release and forever discharge that strip of land in Gantt Township, Greenville County, S. C., known as Morris Court and being more particularly described by deed of Palmetto Realty Corporation to Greenville County dated January 31, 1955, recorded in the R. M. C. Office for Greenville County in Deed Book 517, page 293, from the lien of the judgment in Judgment Roll F-729, Office of Clerk of Court, Greenville County, S. C.
