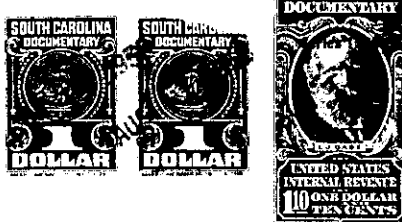
That I, C. F. Putman in the State aforesaid, in consideration of the sum of (625.00) Six Hundred Twenty Five & NO/100 DOLLARS,
