C. FULLER, his heirs and assigns, forever:

ALL that lot of land with the buildings and improvements thereon, situate on the Southeast side of Wade Hampton Boulevard (also known as U. S. Highway No. 29) near Greenville, in Greenville County, South Carolina, being shown as Lot No. 3 on plat of Property of Irene B. Ducker, made by Dalton & Neves, Engineers, October, 1954, recorded in the R.M.C. Office for Greenville County, S. C., in Plat Book "HH", page 132, and having according to said plat the following metes and bounds, to wit:

BEGINNING at an iron pin on the Southeast side of Wade Hampton Boulevard at joint front corner of Lots 2 and 3, and running thence with the line of Lot 2, S. 50-18 E., 325.7 feet to an iron pin; thence N. 42-52 E., 72 feet to an iron pin; thence with the line of Lot 4, N. 47-08 W., 325 feet to an iron pin on the Southeast side of Wade Hampton Boulevard; thence along the Southeast side of Wade Hampton Boulevard, S. 42-52 W., 90 feet to the beginning corner.
