Know All Men by These Presents:

That I, John H. Greer, in the State aforesaid, in consideration of the sum of Twelve Hundred Fifty (\$1250.00) DOLLARS,

Furman Clyde and Julia Thomas Dobson to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s)/(the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Furman Clyde Dobson and Julia Thomas Dobson and their heirs and assigns:

All of that parcel or lot of land in Chick Springs Township of Greenville County, South Carolina, located on the northwest side of the Hammett Bridge Road, about two miles southwest of Greer and near Pleasant Grove Baptist Church, being shown and known as Lot No. 4 and one-half of Lot No. 3 (being the one-half of Lot No. 3 adjacent to Lot No. 4) on a plat of property made for J.H. Greer by W.P. Morrow, Surveyor, dated July 2, 1955, and having the following courses and distances: BEGINNING at a point in the center of the Hammett Bridge Road (iron pin on the northwest bank thereof), corner with Lot No. 5 on said plat, and runs thence with the common line of Lots Nos. 4 and 5 N. 44.30 W. 200 feet to an iron pin; thence N. 42.24 E. 150 feet to a point exactly in the center of rear line of Lot No. 3; thence a new line equally dividing Lot No. 3 S. 44.30 E. 200 feet to a point in the center of the Hammett Bridge Road (iron pin to be placed in bank thereof); thence along said road S. 42.24 W. 150 feet to the beginning corner.

As a part of the consideration, this conveyance is made subject to the following restrictions: The property herein conveyed shall be used for residential purposes only, and no dwelling shall be erected on the premises with less than 1150 square feet of floor space and valued at not less than \$9,000.00. A septic tank shall be required for each dwelling and no outbuilding shall be erected, except a garage. No livestock shall be kept on the premises.

The restrictions are for the benefit of the grantor herein and his heirs and devisees, and also for the benefit of any others who may purchase lots out this subdivision, and should there be a violation of these restrictions, any of these parties may seek injunctive relief and damages.

TOGETHER with all and Singular the Rights, Members, Hereditaments and Appurtenances to the said premises belonging, or in anywise incident or appertaining

TO HAVE AND TO HOLD all and singular the said Premises before mentioned unto the grantee(s) hereinabove named, and their Heirs and Assigns forever.

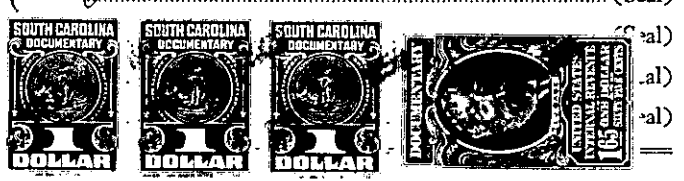
