to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said JAMES EDWARD HENDRIX, his heirs and assigns, forever:

ALL that lot of land with the buildings and improvements thereon, situate on the West side of Old Augusta Road near the City of Greenville, in Gantt Township, Greenville County, South Carolina, being shown as Lot No. 2 on plat of property of Lillie C. Thompson, made by C. C. Jones, Surveyor, September 28, 1951, recorded in the R.M.C. Office for Greenville County, S. C., in Plat Book "DD", at page 53, and having according to said plat the following metes and bounds, to wit:

BEGINNING at an iron pin on the West side of Old Augusta Road at joint front corner of Lots 1 and 2, and running thence with the line of Lot 1, S. 89-11 W., 217 feet to an iron pin; thence S. 0-58 E., 80 feet to an iron pin; thence with the line of Lot 3, N. 89-11 E., 216.8 feet to an iron pin on the West side of Old Augusta Road; thence along Old Augusta Road, N. 0-34 W., 80 feet to the beginning corner.
