complaint in the Court of Common Pleas, for the County aforesaid, against Elizabeth Anne Petty,

demanding relief as to the real estate described in the complaint: and the cause being at issue, came on to
be heard on the 6th day of September 1955,
and such proceedings were had therein as resulted in a decree of the said Court, whereby it was adjudged
and decreed that the said real estate hereinafter mentioned and described, be conveyed by E. INMAN,
Master in and for the County aforesaid, to H. F. Littlefield and Wilma G. Littlefield
for the purposes mentioned in the said decree, as by reference thereto on file in said Court, will appear;

NOW, Therefore, Know all Men by these Preesents, that I, E. INMAN, Master, in and for the County
of Greenville aforesaid, by virtue of the aforesaid decree, and upon receipt of \$1800.00

HAVE GRANTED, conveyed and released, and by these presents, DO GRANT, convey and release
unto the said H. F. Littlefield and Wilma G. Littlefield,

All that certain piece, parcel or tract of land situate in Butler
Township, County and State aforesaid, and being known and designated as
Tract No. 5 and containing twenty and 20/100 (20.20) acres, more or less,
according to a sub-division and plat of the Stewart Gresham place made by
W. M. Nash, Surveyor, Oct. 24, 1929, and having the following metes and
bounds and courses and distances, as shown by said plat, to-wit: Beginning
at a stone on the north bank of Peter's Creek; southwest corner of Tract No.
1 of said subdivision, and running thence along the line of land of Mrs.
W. H. Bridwell S.4.23 W.16.30 to a stone in old road; thence running along
the line of land of C. F. Verdin N.83½ E.18.35 to stone in hollow and at
corner of Tract No. 4; thence running along the line of Tract No. 4, N.3/4
E. 7.00 to stone on north bank of Peter's Creek and in line of Tract No. 3
of said subdivision; thence running along the meanders of said creek as
the line and along the line of Tract No. 3 to corner of Tract No. 1; thence
continuing along the meanders of said Creek as the line and along the line
of Tract No. 1 to the beginning corner. Said land is bounded on the north
by Peter's Creek, on the East by Tract No. 4 of said subdivision, on the
south by lands of C. F. Verdin and on the west by lands of Mrs. W. H.
Bridwell. This being the same property which was conveyed to L. W. Ford and
