Costner, his heirs and assigns,

All that certain piece, parcel and lot of land lying and being in Gantt Township, County of Greenville, State of South Carolina, near the City of Greenville, lying and being in that certain subdivision known as "Belle Meade", being owned by Derby Heights Inc. shown as Lot No. 12 according to a plat made by Piedmont Engineering Service and recorded in the R. M. C. Office for Greenville County S. C. in Plat Book "EE" at Pages 116 and 117 and being more particularly described as follows:

BEGINNING at an iron pin on the west side of Brookforest Drive at the joint front corner of Lots 11 and 12 and running along the line of Lot 11 S. 36-53 1/2. 154.5 feet to an iron pin, joint rear corner of Lots 11 and 12; thence N. 50-40 W. 99.7 feet to an iron pin on Williamsburg Drive; thence along Williamsburg Drive N. 38-30 E. 125.1 feet; thence along the curve of Williamsburg Drive and Brookforest Drive N. 81-51 E. 36.2 feet; thence along Brookforest Drive S. 54-49 E. 70 feet to an iron pin, the beginning corner.

Subject however, to those protective covenants and restrictions, and the easements reserved therein, as recorded in the R. M. C. Office for Greenville County S. C. in Deed Book 505, at Page 73, as amended in Deed Book 521, Page 199.
