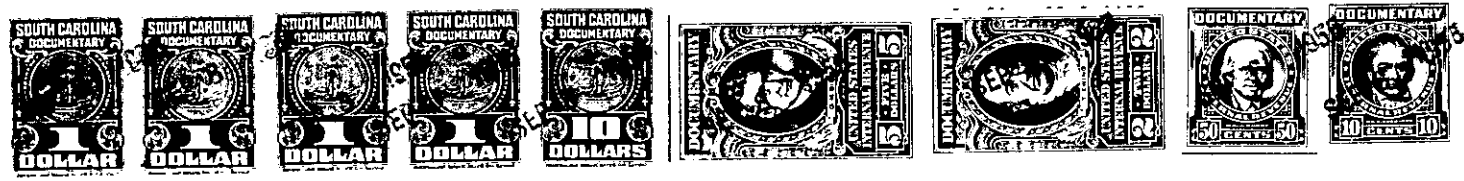
That I, **Rudolph Looper** in the State aforesaid,

A. Pierce, Luma Looper, Kenneth Henson, B. H. Pierce, Elmer Finley, and Tom McCombs**, who are The Board of Deacons For "The Shiloh Baptist Church", as Trustees for the Shiloh Baptist Church, Their Successors or assigns;

All that piece, parcel or lot of land in Bates Township, Greenville County, State of South Carolina, located on the Marietta to Pickens Road, containing ten (10) acres, more or less, and described as follows:

Beginning at a iron pin on the Pickens to Marietta Road, and running thence N. 33 W. 8chs. with a branch to a iron pin; thence S. 25 W. 15 chs. to a iron pin on a new road; thence S. 61-00 E. 8.50 chs. to fork of Pickens and Marietta Road; thence with said road N. 14-00 E. 10 chs. to a stake on the Marietta and Pickens Road; thence with said road N. 25 E. to a iron pin the beginning corner; This being the same property conveyed to Lillie Murr by Henrietta E. Pike on January 16, 1945, Recorded in Vol. 271, page 143.
