to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Gerald J. Teat,

All that lot of land in the county of Greenville, state of South Carolina, near the city of Greenville, being known and designated as Lot No. 9, on plat of Donald E. Baltz, recorded in plat book BB page 175 of the R. M. C. Office for Greenville County, and having according to a recent survey made by R. W. Dalton, August 1955, the following metes and bounds, courses and distances, to-wit:

Beginning at an iron pin on the southwestern side of Myron Lane, the front joint corner of Lots Nos. 9 and 10, and running thence with the joint line of said lots S. 30-01 W. 110 feet to an iron pin; thence N. 59-59 W. 75 feet to an iron pin corner of Lot No. 8; thence with the line of said Lot N. 30-01 E. 110 feet to an iron pin on the southwestern side of Myron Lane; thence with the southwestern side of said Street S. 59-59 E. 75 feet to the beginning corner.
