All my right, title and interest in and to all that piece, parcel and tract of land lying and being in Gantt Township, on the Grove Road, Greenville County, South Carolina, originally containing 51.25 acres, more or less, and being the same lands conveyed to Jeff Ware and Annie Ware by Befamps, Inc., by deed dated October 20, 1941, recorded in Deed Book 238, Page 26⁹. LESS HOWEVER, such portions thereof as may have been conveyed off by deed or deeds executed by Jeff Ware and Annie Ware but including such lands as may have been conveyed therefrom by Jeff Ware individually.

My interest in the said lands is that which descended to me upon the death of my mother, Annie Ware who owned a one-half undivided interest in the said lands and who died intestate about one year ago.
