Know All Men by These Presents:

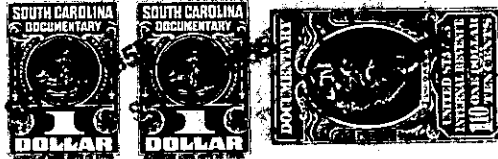

ALL that piece, parcel or lot of land, situate, lying and being in Gantt Township, Greenville County, State of South Carolina and being known and designated as LOT NO. 50 on plat of Pecan Terrace, recorded in the RMC Office for Greenville County in Plat Book "GG", at page 9 and having the following metes and bounds, to wit:

BEGINNING at an iron pin on the Eastern right-of-way line of the Augusta Road at joint front corner of Lots 49 and 50 and running thence with joint line of said lots, South 69-30 East 170 feet to an iron pin at rear corner of Lot 52; thence with the rear line of said lot, South 38-50 West 72.3 feet to an iron pin, corner of Lot 51; thence with the line of that lot, North 72 West 146.2 feet to an iron pin on the Eastern right-of-way line of the Augusta Road; thence with the right-of-way line of said Road, North 19-36 East 75 feet to the beginning corner.
