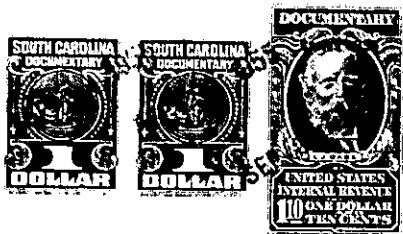

All that certain piece, parcel or lot of land in the State of South Carolina, County of Greenville, on the eastern side of Elizabeth Drive, Chick Springs Township, being shown as Lot No. 227 on plat of property of Robert J.
