All that certain piece, parcel or lot of land in the State of South Carolina, County of Greenville, on the northeastern side of Harding Drive being known and designated as Lot No. 7 as shown on plat of Buckhorn Hills dated December, 1954, and being more particularly described according to said plat as follows:
