

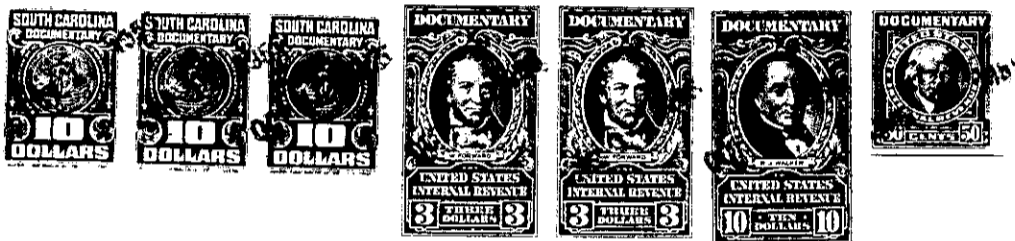
STATE OF SOUTH CAROLINA, GREENVILLE COUNTY

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said J. C. Keys, Jr., his heirs and assigns forever:

All that piece, parcel, or lot of land, with the buildings and improvements thereon, in the City of Greenville, County of Greenville, State of South Carolina, on the north side of West Washington Street, in the block between Hudson Street and Butler Avenue, which lot has a frontage on West Washington Street of 68 feet, more or less, and runs back a distance of 260 feet, more or less, to John Street, being the same lot or parcel of land as was owned and conveyed to the grantor by The Sarah S. Gossett Home, by deed to be recorded hereafter. This property is shown on the City Block Book as Lot 1, Section 2, Page 16.

And the grantor(s) do(es) hereby bind the grantor(s) and the grantor's(s) Heirs, Executors and Administrators to warrant and forever defend all and singular the said premises unto the grantee(s) hereinabove named, and the grantee's(s) Heirs and Assigns against the grantor(s) and the grantor's(s) Heirs and against every person whomsoever lawfully claiming or to claim the same or any part thereof.
