All that lot of land near the city of Greenville, in the county of Greenville, state of South Carolina, being known and designated as Lot No. 11 on plat of Donald E. Baltz recorded in plat book BB page 175 of the R. M. C. Office for Greenville County, and having according to a recent survey made September 1955, by R. W. Dalton, the following metes and bounds, courses and distances, to-wit:

Beginning at an iron pin on the southwestern side of Myron Lane, the front joint corner of Lots Nos. 10 and 11; thence with the southwestern side of said Street S. 59-59 E. 23.9 feet to an iron pin; thence S. 49-12 E. 44.3 feet to an iron pin; thence continuing with the southwest side of said Street S. 27-43 E. 44.3 feet to an iron pin; thence with the curve of said Street as it intersects with Crestfield Road, the chord of which is S. 27-54 W. 11.3 feet to an iron pin on the northwestern side of Crestfield Road; thence with the northwestern side of said Road S. 72-54 W. 105 feet to an iron pin; thence N. 22-00 W. 44.3 feet to an iron pin rear corner of Lot No. 10; thence with line of said lot N. 30-02 W. 110 feet to the beginning corner.

This being a portion of the same property conveyed to grantor by W. W. Wilkins by deed dated December 31, 1954 recorded in volume 515 page 155 of the R.M.C. Office for Greenville County.

TO HAVE AND TO HOLD all and singular the said Premises before mentioned unto the grantee(s) hereinabove named, and his Heirs and Assigns forever.

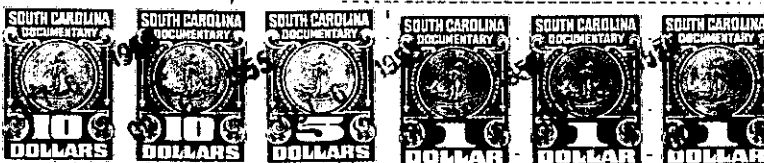
