

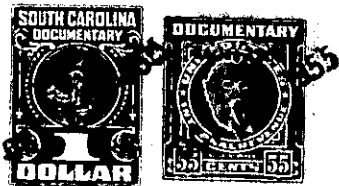

to us in hand paid at and before the sealing of these presents by Zola McCarter, Alvin Lindsey and Devant Sanders, as Trustees of the Faith Tabernacle of the House of Prayer of Greenville, S. C.

(the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Zola McCarter, Alvin Lindsey, and Devant Sanders, as Trustees of the Faith Tabernacle of the House of Prayer of Greenville, S. C., and their successors and assigns in fee simple forever:

all that piece, parcel or lot of land in Township, Greenville

County, State of South Carolina, shown on map of "Donwood" which said map is recorded in office of the R. M. C. for Greenville County in Plat Book A at page 462, and being known and designated as lots number 80 and 81 on said plat or map and described by courses and distances as follows, to-wit:

BEGINNING at a point on the South side of Iola Street at corner of Honour property and running thence along the South side of said street N. 74-26 E., 100 feet to corner of Lot No. 79; thence along the joint line of Lot No. 79 and 80, N. 15-20 W., 150 feet to joint corner of Lots 79, 80, 83, and 84; thence along the joint line of Lot 80, 81, 82 and 83, on the degree of S. 74-26 W., 100 feet to the corner of the Honour property; thence S. 15-20 E., 150 feet to the beginning corner.

ALSO: All that certain piece, parcel or lot of land situate, lying and being in the "Donwood" subdivision in Greenville County, S. C., on Marion Street of said subdivision, and being known and designated as lot number 83 on plat recorded in Book A at page 463 and has according to said plat the following metes and bounds, to-wit:

BEGINNING on Marion Street at joint corner of lots 83 and 84 and running with the joint line of lots 83 and 84, S. 15-20 E., 150 feet to the joint corner of lots 83, 84, 80 and 79; thence with joint rear line of lots 83 and 80, S. 74-26 W., 50 feet to joint corner of lots 83, 80, 82, and 81; thence with line of lots 83, 82, N. 15-20 W., 150 feet to corner of lots 82 and 83 on Marion Street; thence with Marion Street, N. 74-26 E., 50 feet to the point of beginning, and being the same tract of land conveyed to the grantors herein by Deed dated March 20, 1953, recorded in said R. M. C. Office in Deed Book 475 at page 262.

For the consideration herein expressed and paid, it is irrevocably provided and agreed that the Faith Tabernacle of the House of Prayer of Greenville, S. C., is forever, completely and entirely released and discharged, in law and equity, from any liability, duty, obligation, or connection with, in or to, the National, State or General House of Prayer
