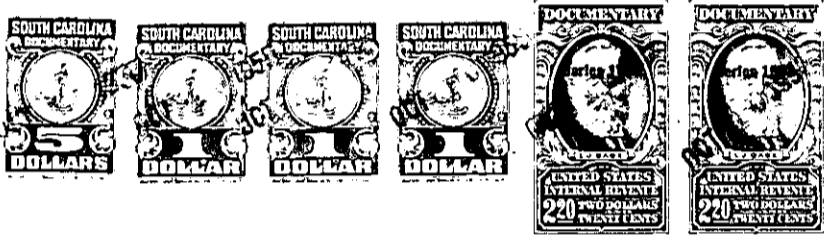
That Elizabeth M. Toohey in consideration of the sum of Thirty-seven Hundred Fifty and No/100 (\$3750.00) DOLLARS,
