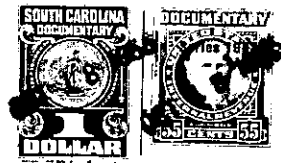

All that certain parcel or tract of land in Chick Springs Township, Greenville County, State of South Carolina, on the Southern side of Reid School Road and having more or less to survey made by W. E. Dalton, February, 1954, the following is a true and correct description:

BEGINNING at an iron pin on the Southern side of Reid School Road at the corner of Lot this day conveyed to M. O. Center and running thence S. 1-43 E. 107.7 feet to iron pin in line of other property of the Grantor; thence with the line of said property S. 81-57 W. 10 feet to iron pin; thence with other line of property of grantor N. 1-03 E. 107.7 feet to iron pin on Reid School Road; thence with said road N. 82-57 E. 100 feet to iron pin, point of beginning.

- It is understood that this conveyance is made subject to the following restrictions:
1. Said property shall be used exclusively for residential purposes.
 2. No dwelling shall be constructed upon said lots costing less than \$10,000, nor containing less than 800 Square Feet of floor space exclusive of porches and pavilions.
 3. No dwelling shall be built nearer than 60 feet from the front property line of said lots.
