to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said

ANN D. BROWN, her heirs and assigns:

All that piece, parcel or lot of land, situate, lying and being near the City of Greenville, in the County of Greenville, State of South Carolina, being known and designated as Lot No. 83, according to Plat of Section I of Lake Forest, which plat is recorded in the R. M. C. Office for Greenville County, South Carolina, in Plat Book "GG", page 17, and having, according to said plat, the following metes and bounds, to wit:

BEGINNING at an iron pin on the Northerly side of Lake Fairfield Drive, ... front corner Lots 82 and 83 running thence N. 21-30 E. 178.2 feet to an iron pin in the rear line of Lot 83 being the joint rear corner Lots 82 and 83; thence along the rear line of Lot 83 N. 67-37 E. 84.9 feet to an iron pin on the Westerly side of Shannon Drive; thence along the Westerly side of Shannon Drive S. 23-31 E. 154.0 feet to an iron pin; thence around the curve of the intersection of Shannon Drive and the Fairfield Drive, the chord of which is S. 18-52 W. 33.3 feet to an iron pin on the Northerly side of Lake Fairfield Drive; thence along the Northerly side of Lake Fairfield Drive S. 21-11 W. 80 feet to an iron pin, the point of beginning.
