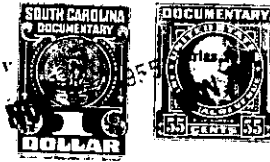

That I, H. W. Fore in the State aforesaid, in consideration of the sum of TWO HUNDRED EIGHTY & NO/100 (\$280.00) DOLLARS,

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said

James W. Owens and Thelma Owens, their heirs and assigns, forever:

All that piece, parcel or lot of land in the State and County aforesaid, being known and designated as Lot Nos. 118 on a plat of Brookwood recorded in the R.M. C. Office for Greenville County in Plat Book BB, at page 27, and having, according to said plat, the following courses and distances, to wit:

BEGINNING at an iron pin on the Northern side of Gantt Drive at the joint front corner of Lot Nos. 118 and 119 and running thence with the joint line of said lots N. 3-13 E. 180 feet to an iron pin; thence N. 86-56 W. 86.9 feet; thence S. 3-15 W. 179 feet to an iron pin on the Northern side of Gantt Drive; thence with Gantt Drive S. 86-15 E. 86.9 feet to the beginning corner.

This conveyance is subject to the following restrictions:

That the saidlands shall not be sold, rented or otherwise disposed of to any negro or person of African descent; no residence to cost less than Five Thousand (\$5,000.00) Dollars shall be erected on said lots; no residence shall be erected on any lot nearer than Thirty-five (35) feet to the front line; no residence shall be erected on any lot unless said lot has fifty (50) feet, or more frontage; no outside toilets permitted and sewage to be disposed of by approved septic tanks.

This conveyance is subject to all easements and rightsofway of record.
