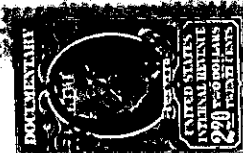

Know All Men by These Presents:

That I, J. H. Sitton, Trustee for J. H. Sitton, C. E. Robinson, Jr. and R. M. Gaffney, in the State aforesaid, in consideration of the sum of One (\$1.00) Dollar and exchange of Real Estate valued at Thirty-Seven Hundred Fifty and no/100 (\$3,750.00) Dollars, to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said

Lake Forest, Inc., its successors and assigns:

All that certain piece, parcel or lot of land lying and being on the southerly side of Hermitage Road, near the City of Greenville, S. C., being shown as Lot No. 1 on the plat of Timberlake as recorded in the RMC Office for Greenville County, S. C. in Plat Book "BB", page 185, and having according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on the southerly side of Hermitage Road at a point 79.8 feet east of the southeasterly corner of the intersection of Selwyn Drive and Hermitage Road, said pin being the joint front corner of Lots Nos. 1 and 2, and running thence along the joint line of said lots S 3-19 E 183 feet to an iron pin on the line of Lot No. 3; thence along the line with Lot No. 3 S 82-15 E 82 feet to an iron pin on the line of the lot herein conveyed and Lot No. 125, Section 3, Lake Forest (Plat Book "GG", pages 76-77); thence along the joint line with said lot N 6-23 E 235 feet to an iron pin on the southerly side of Hermitage Road; thence along the southerly side of Hermitage Road S 71-26 W 125 feet to the point of beginning.

This is part of the property conveyed to the grantor by the deed recorded in Deed Book 528, page 103, and this conveyance is made pursuant to the authorities and powers granted the Trustee in said deed.
