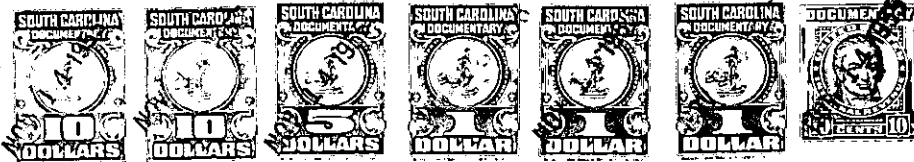

All that lot of land situate on the West side of Scarlett Street (formerly known as Forest Green Road), near the City of Greenville, in Greenville County, South Carolina, being shown as Lot 221 on plat of Sherwood Forest, made by Dalton & Neves, Engineers, August 1951, revised through June 1953, recorded in the R.M.C. Office for Greenville County, S. C., in Plat Book "000", at pages 70 and 71, and having according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the West side of Scarlett Street at joint front corner of Lots 220 and 221, and running thence with the line of Lot 220, S. 83-02 W. 170 feet to an iron pin; thence N. 2-28 W. 75.2 feet to an iron pin; thence N. 83-02 E. 164.1 feet to an iron pin on the West side of Scarlett Street; thence with the West side of Scarlett Street S. 6-58 E. 75 feet to the beginning corner.

TOGETHER with all and Singular the Rights, Members, Hereditaments and Appurtenances to the said premises belonging, or in anywise incident or appertaining.

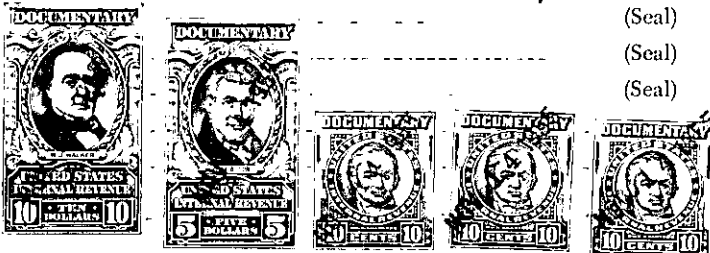
