All that lot of land in the County of Greenville, State of South Carolina, Chick Springs Township, being known as lots nos. 41 and 42 according to plat of Edwards Forest made by Woodward Engineering Co. dated January, 1955 and recorded in the R.M.C. Office for Greenville County in Plat Book EE at Page 105 and having, according to said plat, the following metes and bounds, to-wit:
