To All Whom These Presents Shall Come:

I, E. INMAN, Master in and for the County aforesaid, SEND GREETING:

WHEREAS, Pauline T. Brown, et al.,

on or about the 20th day of October in the year of  
our Lord nineteen hundred and fifty-five exhibited their  
County  
complaint in the Court of Common Pleas, for the County aforesaid, against  
Robert Lester Brown, et al.,

demanding relief as to the real estate described in the complaint: and the cause being at issue, came on to  
be heard on the 3rd day of November 1955,  
and such proceedings were had therein as resulted in a decree of the said Court, whereby it was adjudged  
and decreed that the said real estate hereinafter mentioned and described, be conveyed by E. INMAN,  
Master in and for the County aforesaid, to B. H. Meeks  
for the purposes mentioned in the said decree, as by reference thereto on file in said Court, will appear;

NOW, Therefore, Know all Men by these Presents, that I, E. INMAN, Master, in and for the County  
of Greenville aforesaid, by virtue of the aforesaid decree, and upon receipt of \$1050.00

HAVE GRANTED, conveyed and released, and by these presents, DO GRANT, convey and release  
unto the said B. H. Meeks

"All that piece, parcel or lot of land situate, lyin. and being in  
Greenville Township, County and State aforesaid, being known and designated  
as a portion of lots 13 and 14 on plat of property of J.A. Heatherly, re-  
corded in Plat Book E, Page 235, and havin. the following metes and bounds,  
to-wit:

BEGINNING at an iron pin on Judson Road, at corner of Lot conveyed by  
Sallie Mae Lunsford to W. F. Lunsford, and running thence along Judson Road  
S. 08 W. 93.9 feet; thence S. 52-39 E. 49.0 feet to iron pin, corner of  
Lot 15; thence along line of said lot, N. 33-29 E. 109.2 feet to corner of  
L. E. Harden; thence along line of said lot S. 73-05 E. 94.2 feet to the  
beginning."

This deed conveys all of the right, title and interest of Robert Leste  
Brown, Fred Wilmer Jacks, Fred Darrell Jacks, George Oscar Jacks, Revecca  
Annette Jacks to the property of which said Defendants did receive an in-  
terest by way of inheritance from their mother, Ruby F. Brown as the same  
would appear by reference to deed Book 148, at Page 158 and Deed Book 157,  
at Page 486. The purpose of conveyance being to convey to B. H. Meeks all  
the interest of said parties in said property at the intersection of Third  
Avenue, Judson Road and King Street in the County of Greenville; State of  
South Carolina.
