to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said

C. E. Robinson, Jr. and R. M. Gaffney, their heirs and assigns forever:

All that certain piece, parcel or lot of land lying and being on the southeasterly side of Selwyn Drive, near the City of Greenville, S. C., being shown as Lot No. 33 on the plat of Timberlake as recorded in the RMC Office for Greenville County, S. C. in Plat Book "BB", page 185, and having according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on the southeasterly side of Selwyn Drive at a point 1174.1 feet north of the northeasterly corner of the intersection of Selwyn Drive and Spartanburg Road, said pin being the joint front corner of Lots Nos. 32 and 33, and running thence along the joint line of said lots S 46-12 E 248.7 feet to an iron pin in the line of Lot No. 38; thence along the line with Lot No. 38 N 34-38 E 50 feet to an iron pin, joint rear corner of Lots Nos. 33 and 34; thence along the joint line of said lots N 31-23 W 224.7 feet to an iron pin on the southeasterly side of Selwyn Drive; thence along the southeasterly side of Selwyn Drive S 60-06 W 59.1 feet to an iron pin; thence continuing along the southeasterly side of said Drive S 51-16 W 50.1 feet to the point of beginning.
