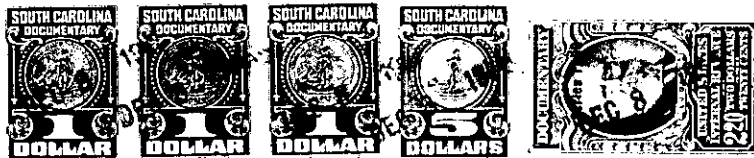
to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Leon Marder, his heirs and assigns forever:

All that certain piece, parcel or lot of land lying and being at the southeasterly corner of the intersection of Selwyn Drive and Hermitage Road, near the City of Greenville, S. C., being shown as Lot No. 2 on the plat of Timberlake as recorded in the RMC Office for Greenville County, S. C. in Plat Book "BB", page 185, and having according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on the southerly side of Hermitage Road at the joint front corner of Lots Nos. 1 and 2, and running thence along the southerly side of said Road S 71-26 W 79.8 feet to an iron pin at the southeasterly corner of the intersection of Hermitage Road and Selwyn Drive; thence around said intersection on a curve, the chord of which is S 38-09 W 58.3 feet to an iron pin on the easterly side of Selwyn Drive; thence along the easterly side of Selwyn Drive S 4-53 W 93.4 feet to an iron pin, joint corner with Lot No. 3; thence along the joint line with Lot No. 3 S 82-16 E 130 feet to an iron pin, joint rear corner of Lots Nos. 1 and 2; thence along the joint line with said lots N 3-19 W 183 feet to the point of beginning.

This is part of the property conveyed to the grantor by deed recorded in Deed Book 528, page 103, and this conveyance is made pursuant to the authority and powers granted the trustee in said deed.
