That I, C. E. Lloyd in the State aforesaid, in consideration of the sum of One Thousand and Fifty (\$1050.00) - - DOLLARS,

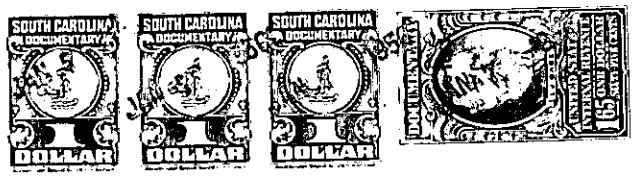

All that certain piece, parcel or lot of land in the County of Greenville, State of South Carolina, known and designated as Lot No. 9 on Plat of Property of C. E.
