to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Ledger Brownlow Shope, his heirs and assigns forever:

All that piece, parcel or lot of land situate, lying and being in Gantt Township, Greenville County, State of South Carolina on the western side of Dolphin Street and being known and designated as Lot No. 24 of Greenfields, Section No. 3 as shown on plat thereof prepared by C. C. Jones, Engineer dated October, 1954 and recorded in the R. M. C. Office for Greenville County in Plat Book "GG", at Page 93 and having according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on the western side of Dolphin Street, joint front corner of Lots Nos. 23 and 24 and running thence along the joint line of said lots S. 80-42 W. 147.2 feet to an iron pin; thence N. 11-55 W. 70 feet to an iron pin at the rear corner of Lot No. 25; thence along the line of that lot N. 78-05 E. 147.7 feet to an iron pin on the western side of Dolphin Street; thence along the western side of Dolphin Street S. 11-20 E. 76.6 feet to the beginning corner.
