ALL that piece, parcel or lot of land in Gantt Township, Greenville County, State of South Carolina, being known and designated as Lot No. 23 of a subdivision known as Section "C", of Englewood Estates, as shown by a Plat thereof, dated December, 1951, recorded in the R. M. C. Office for Greenville County in Plat Book, "B", at Page 13.

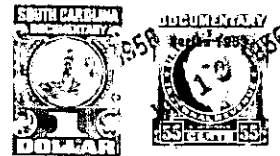
BEGINNING at an iron pin on Cheyenne Drive at joint front corners of Lots No. 22 and 23 and running thence along the line of said Lot No. 22, S. 2-30 W. 158.3 feet to iron pin in line of Lot No. 26; thence along the line of said Lot No. 26, N. 81-33 W. 80.5 feet to iron pin in line of Lot No. 25; thence along the line of said Lot No. 25, N. 2-30 E. 150 feet to iron pin on Cheyenne Drive; thence running with the said Cheyenne Drive, S. 87-30 E. 80 feet to iron pin at point of beginning.

THIS deed is made subject to the following restrictions:

- 1. No house is to be erected costing less than \$5,000.00.
2. No house is to be built closer than fifty (50) feet to the street.
3. No temporary house is to be erected on said lot.

THIS deed is subject to any rights-of-way now existing.
